I've been wanting to update the membership on what the situation is concerning this year's dates, purses, and any related concerns the membership might have. However, any information available was not factual and written in stone except for the fact we would have a 30-day race meet this year.

We now know Arapahoe Park will have a 30 day meet, starting August 16th and ending October 21st. Probably each race day will have 7 or 9 race cards if the horse population is sufficient. In my conversation with Shannon Rushton, he couldn't, as-of-yet, pinpoint exactly the conditions

of the purse structure. However, he did say the purses would probably be very similar to two years ago. Hopefully, these conditions will facilitate a horse population that will enable us to have a credible meet.

Last year because of track restrictions and the lack of electricity in the barn area, HISA didn't allow Arapahoe Park to send its signal to the outside world. Naturally, this affected our breeders' fund money that is negatively affected when we have no signal going to the outside world. However, I have been told this year we will have HISA approval on sending our signal. This should have a positive effect on our breeder's fund total at the end of the year.

At the last CTBA board meeting we set the dates for our stakes schedule this year. Our Colorado bred stakes will run at a \$25,000.00 estimated value. This was the best the board felt was possible because of last years HISA restrictions. Hopefully, Colorado breeders will support all of our stakes with suitable numbers and participation so we can run every stakes race as scheduled. I can't emphasize enough how badly we need to have Colorado breeders support all the Colorado bred races and stake races at the track this year. Your participation is so important for the next year when we ask Arapahoe Park for monetary participation in our Colorado bred racing program.

Nomination forms for our stake races are included with this newsletter. Please see the "Dates to Remember" for important deadlines. Our registrations are up slightly this year with the CTBA. Hopefully, this means we will have more Colorado bred horses running.

If anyone is interested in running for the CTBA Board, please notify Tonya immediately. Resumes are due in the CTBA office no later than 3pm Friday, May 9th, 2025. The Annual Meeting will be held at Arapahoe Park in the Director's room (unless told otherwise) at 10:30am on Saturday, June 14th.

Have a prosperous summer, and here is hoping Arapahoe Park can have a very successful meet this year. Just a final note, Shannon Rushton is doing one fine job in trying to make Arapahoe Park and Colorado racing successful.
